### **SPECIAL ORDERS:**

No special order item may be cancelled or returned. Payment in full or part may be required for any special order item before it is ordered or produced.

# **CANCELLATIONS:**

All cancellations must be reported to the sales department by telephone and followed by written or faxed confirmation.

#### SHIPMENTS:

Freight allowed shipments will be made on the carrier of our choice.

#### **DAMAGES:**

All of our merchandise is packed with great care by experienced packers. Our responsibility for safe delivery ceases once the freight carrier receives the merchandise. We will however, be happy to file any damage claim for you if the following requirements are met:

1) If a shipment is damaged by UPS please accept the package in this condition and call us within 24 hours. At this time we will advise you as the disposition of the damaged portion of each individual shipment.

2) If a shipment is damaged by a truck line carrier, please notate on the freight bill exactly what type and how many lamps are broken and have the driver sign your copy of the bill. Ex: 15 PCs. F40 CW broken out of 1 Case of 30.

In case of defective material, we will, at our option, repair or replace. Lamps must be returned for our inspection.
